# Rules and guidelines

**Title of your artwork** (Up to 10 words)

Full name of the author and holder of the right to use the scientific illustration In this contest we will only accept artwork in which the author and the holder of the right to use the scientific illustration are the same person. Only one author per artwork.

# **Description for your artwork**

Text of up to 150 words describing (what is the scientific illustration?; software/AI used to obtain the scientific illustration, if any; prompt used in the case of generative AI use; treatment for editing or manipulation, if applicable)

## 1. THEME: Natural products-Inspired Art for Health

#### 2. PARTICIPATION

The Exhibition will be held during ICNPHH-2024, from September 18th to 20th, 2024.

## 3. RULES FOR SENDING ARTWORKS

Only unpublished works will be accepted, that is, works that have not yet been partially or fully published, including on the internet, and that meet the indicated requirements.

Each participant will be able to submit **two works**.

The artworks may be colored or in black and white and must be sent in digital format, with following standards:

- Photographs must be sent in JPEG, TIFF format. The minimum image size must be 1000 x 1000 px and a maximum of up to 4800 px on its largest side (vertical or horizontal). The file size in megabytes must be a maximum of 04MB.
- Authors must upload the file via Google Drive and insert the link with access permission in a specific area of the event website by August 15, 2024.
- The photographs sent must be free from marks that identify the author or logo.

- Photographs cannot be manipulated such as: removing or adding part of the main subject, relocating subjects and content, changing color, using a filter, cutting more than 40% of the original image or having been digitally distorted.
- The author must title the artwork.
- The author must provide authorization to use images if their work includes private people and places.
- The artworks sent cannot have content that:
  - May cause damage to third parties, whether through defamation, insult or material damage and/or moral damage.
  - Constitute an offense against freedom of belief and religions.
  - Have the intention of promoting a product, service or any commercial purpose.

#### 4. SELECTION AND DISCLOSURE OF THE BEST Works

 The selection of the 10 best entries will be made by a Judging Committee, for exhibition during the ICNPHH-2024, based on creativity, originality, scientific and artistic value. Of these, the 3 (three) best artworks will be selected and the respective awards will be announced during the closing ceremony of the ICNPHH-2024, on September 20, 2024.

To preserve the fairness of the process, the Organizing Committee reserves the right to only disclose the names of the members of the Judging Committee when revealing the 3 (three) best works, at the closing ceremony of ICNPHH-2024.

#### 5. GENERAL PROVISIONS

The UNIFIPA (CEPEC) is exempt from liability for moral or material damages resulting from the use of the image to publicize the competition or for exhibition, with the author being solely responsible.

Simply registering for the event will give the Organizing Committee the right to use the participants' images, photos and testimonials on the website and in other promotional materials, with due credit reference. There cannot be any copyright charges.

Simply registering for the Artwork Contest already presupposes acceptance and agreement with all the terms of these Regulations. The registration also recognizes the absence of plagiarism, fully assuming authorship.

The UNIFIPA (CEPEC) may suspend the Competition, without any participant having the right to complain.
